Foreword

It is indeed my proud privilege to present this Annual Report of the Agricultural Scientists Recruitment Board (ASRB) for the period from 1st April, 2021 to 31st March, 2022. The report gives an elaborate account of the major activities undertaken by ASRB and its achievements during the year.

The recruitment process was deferred for some time for revamping of the scorecard for recruitment of senior scientific



posts (both RMPs and Non-RMPs) of ICAR to make it more objective in order to bring transparency in the selection process and to compute the screening process at ASRB. Now, scorecard for direct selection to senior scientific positions of ICAR on lateral entry bases has been revamped and made completely objective in order to computerize the screening process at ASRB.

After revamping of the scorecard, Board advertised 90 Research Management Positions (RMP) vide Advt. No.1/2021, comprising of four posts of Deputy Directors General, two posts of Directors of National Institutes, seventeen posts of Assistant Directors General, fifty seven posts of Directors of other than National Institutes, two posts of Project Directors and the remaining being Joint Directors. The Board completed the recruitment process for five RMP posts including three Deputy Directors General and two Directors of National Institutes within two months of the advertisement. Recruitment process for other posts is going on and very soon it will be completed.

As a part of time bound implementation of the Career Advancement Scheme (CAS) for ARS Scientists, 78 proposals in thirty five disciplines for placement from Senior Scientists to the grade of Principal Scientists were processed and cleared during the year. About 89.74 percent (including 5.13 percent deferred promotion) of the candidates were recommended for promotion to the next higher grade.

During the year, a combined examination for ARS 2021 (Preliminary) for 222 vacancies of Scientists in 48 disciplines, Senior Technical Officers (STO) for 65 positions and National Eligibility Test (NET-2021) in 60 disciplines was conducted in online mode at 32 centers across the country from $23^{rd} - 27^{th}$ August, 2021. A total of 68,473 candidates had registered for the examination and 47,326 candidates actually appeared in the examination. In NET examination, a total of 11,058 candidates qualified for NET certificate.

Executive Summary

This report presents a detailed account of the programmes and activities that ASRB undertook in discharge of its mandate of talent search, assessment and input for policy formulation concerning scientific cadre. The period of this Annual Report 2021-22 is particularly significant for revamping of the scorecard-2021 for direct selection to senior scientific positions on lateral entry basis in Indian Council of Agricultural Research.

During the year, a combined examination for ARS-2021 (Preliminary) was conducted in online mode for 222 vacancies of Scientists in 48 disciplines, Senior Technical Officer (STO) for 65 positions and National Eligibility Test (NET) in 60 disciplines at 32 centres across the country from 23rd-27th August, 2021. A total of 68,473 candidates had registered for the examination while 47,326 candidates actually appeared in the examination. A total of 11,058 candidates qualified in National Eligibility Test in 60 disciplines.

Based on the performance of written test & interview, 63 candidates were recommended for appointment to the post of STO (T-6) in ICAR.

During the period, the Board advertised 90 Research Management Positions vide Advt. No.1/2021, comprising of four posts of Deputy Directors General, two posts of Directors of National Institutes, fifty seven posts of Directors of other than National Institutes, seventeen posts of Assistant Directors General two posts of Project Directors and the remaining being Joint Directors.

The Board completed the recruitment process for five posts, which included three Deputy Directors General and two Directors of National Institutes. There were 58 applicants against these positions, of which 32 candidates were called for interview.

During the year, the Board processed 78 proposals of Senior Scientists due for promotion to Principal Scientists under Career Advancement Scheme (CAS) in 35 disciplines. The overall promotion was 89.74% including 5.13% deferred promotion.

For ease of access, certificates of NET Examination from 2019-20 onwards were uploaded and made accessible on DIGILOCKER of MeitY, Govt. of India.

ASRB implemented the Official Language Policy of Govt. of India in letter and spirit. All possible assistance and facilities, including options in interviews were provided to the candidates for use of Official Language. Efforts were made to procure maximum possible books in various fields in Hindi to enrich ASRB library for the benefit of officers, staff and visitors including the experts/advisors/paper setters/evaluators.

Special drives were taken during the period to regularly update, upscale and expand the question bank and advisor/expert databases in each discipline through online inputs and regular digitization.

Transparency in working is indeed the hallmark of any organization. This particularly applies to a national recruitment body like ASRB. Whether it is screening of work profile of candidates or interviews or examination processes or even empanelment of advisors/ examiners/paper setters/evaluators, etc., the Board has established mechanism of internal scrutiny to ensure objectivity, transparency and quality at all levels.





As regard the matters, grievances or cases involving ASRB admitted/ examined by various courts of law, no instance stricture, by adverse comments, or observations, etc. were made with regard to the decisions of the Board.

The new office building of ASRB in the Pusa Campus is at the stage of completion.

Online Application & Scorecard Information System (OASIS) software for inviting online applications and scrutiny of applications for RMP positions has been developed in house with the help of ICAR-IASRI. OASIS has been successfully tested and implemented by inviting applications of senior RMP positions against the Advt. No.1/2021.



Introduction

Historical Background

Since August 2018, ASRB is functioning as an attached office of the Department of Agricultural Research & Education (DARE) under Ministry of Agriculture & Farmers Welfare, Government of India. Prior to Agricultural Scientists Recruitment Board established by the Government of India in 1973, was an independent recruitment body of Indian Council of Agricultural Research.

As per its mandate, ASRB plays a key role in recruitment of best quality scientists and other management personnel for ICAR and its research institutes across the country. In addition, the Board aids and advises the Council in areas concerning evolving and implementing policies related to induction of human resource and its development including the Career Advancement Schemes for ARS Scientists. Ever since its establishment, ASRB has consistently been endeavouring to reform and refine talent-search strategies to meet existing as well as emerging needs of the National Agricultural Research and Education System (NARES).

Mandate

Mandate of ASRB is to make available the best human resource to man various positions in ICAR and its institutes across the country. As per the Cabinet decision, the Board was initially assigned the following responsibilities:

 Recruitment to posts in the Agricultural Research Service (ARS) of ICAR and to such other posts and services as the President, ICAR, may specify from time to time.

- Rendering such other assistance to the Council in personnel matters, including promotions as may be required by the President, ICAR.
- Advising the Council on disciplinary matters relating to personnel recruited through ASRB or appointed by the Council in consultation with the Board.

Subsequently, after creation of ARS as an All-India Service, following additional responsibilities were also assigned to the Board:

- Recruitment to the entry level scientists grade of ARS through an All-India Competitive Examination.
- Induction of existing scientists of ICAR to ARS under initial constitution of the ARS.
- Assessment for merit promotion and grant of advance increments to scientists of ARS.


In addition, ASRB has also been entrusted the task of recruitment for technical service, administrative and accounts management posts such as Administrative Officers/Finance & Accounts Officers and Assistant Directors (OL).

The Board also conducts National EligibilityTest(NET)in60 approved disciplines, and it is pre-requisite for the candidates to qualify this examination for consideration for appointment as Assistant Professor/ Lecturer in the State Agricultural Universities (SAUs).



Organization

The Board comprises of a Chairman and three Members assisted by a Secretary in the Joint Secretary grade to effectively discharge its responsibilities. Besides, the Board has also proposed one post of Controller of Examination, five Deputy Secretaries/ Deputy Director (Finance) along with other financial, administrative and technical functionaries. The revamped organizational structure of ASRB is shown as under:



Total sanctioned strength of regular officers and staff of the Board as on 31st March, 2022 was 84 (*Appendix I*). Against sanctioned strength, 34 regular employees were in position. List of officers and staff of the Board actually in position during the period from 1st April, 2021 to 31st March, 2022 is given in *Appendix II*.

Expenditure

The Board has incurred an expenditure of ₹2,478.06 lakh during the period from

1st April, 2021 to 31st March, 2022 and revenue received from various sources mainly examinations/applications is ₹628.86 lakh. Details of receipts and expenditure are given in *Appendix III*.

Activities

In discharging its mandated functions, the Board under took various activities. A detailed account of these activities and accomplishment made during the past five years is presented in *Appendix IV*.

Important events

ASRB Board meetings

Three meetings of the Board were held during the period to discuss important matters and issues pertaining to recruitment and assessment.

New office building of ASRB

The construction work of new office building in the premises of Pusa campus has almost been completed. It is expected that Board may move in its own office building by Feb-March, 2023.

During the year, a combined examination for ARS-2021 (Preliminary) for 222 vacancies of Scientists in 48 disciplines, Senior Technical Officer (STO) for 65 positions and National Eligibility Test (NET) in 60 disciplines was conducted in online mode at 32 centers across the country from 23rd-27th August, 2021. A total of 68,473 candidates registered for the combined examination and 47,326 candidates actually appeared in the examination.

National Eligibility Test (NET) - 2021

A total of 60,402 candidates registered for NET but only 42,943 candidates appeared for the test. Out of 42,943 candidates, a total of 11,058 candidates qualified. The NET is an essential prerequisite qualification for determining eligibility for recruitment of Lecturers/Assistant Professors in State Agricultural Universities (SAUs) and other general universities with Agricultural Faculty.

ARS Examination - 2021

A combined examination of ARS (Prelim)/ NET/STO-2021 was held in online mode from 23rd -27th August, 2021, a total of 38,022 candidates registered for the ARS examination. However, only 27,433 candidates appeared in preliminary examination. A total of 2,792 candidates in 48 disciplines qualified for main examination. The main examination was held on 28th November, 2021. The candidates who obtain a minimum qualifying mark in the main examination as decided by the Board are eligible to be called for viva-voce. However, a maximum of 5 candidates against each post shall be called for interview.

Senior Technical Officer (STO)

A total of 17,805 candidates registered for STO in the combined examination of ARS/NET/STO-2021ofwhich12,920candidates actually appeared in the examination. Based on result of the combined examination, only 304 candidates were called for interview for 65 posts of Senior Technical Officer (STO) (T-6). Interview for the posts of STO was held from $2^{nd} - 15^{th}$ March, 2022. A total of 63 candidates were recommended for appointment to the posts of Senior Technical Officer (T-6) under Indian Council of Agriculture Research (ICAR). Two vacancies could not be filled due to non-availability of suitable candidates.

Recruitment of candidates belonging to SC/ST/OBC/PwBD and EWS categories

The Board recommended the candidates belonging to Scheduled Caste (SC), Scheduled Tribe (ST), Persons with Benchmark Disabilities (PwBD), Other Backward Classes (OBC) and Economically Weaker Section (EWS) for the posts of Senior Technical Officer as per rules of ICAR/Government of India. Breakup of selected candidates and number of advertised vacancies in each category are given as below:



During the period, Board advertised 90 Research Management Positions (RMP) vide Advt. No.1/2021 dated 5th Nov, 2021, comprising Deputy Directors General, Directors of National Institutes, Assistant Directors General, Directors of other than National Institutes, Project Directors and Joint Directors of the National Institutes. Positionwise breakup of various posts advertised during the year 2021-22 is as below:

Recruitment process for senior scientific posts (both RMPs and Non-RMPs) of ICAR was put on hold in Feb, 2021 due to revamping of the scorecards. The process of recruitment was started again in November, 2021 after the approval of new revised and revamped scorecards for RMP positions.

The aim of revamping was to make it more objective by minimizing interventions and discretion of human experts in evaluation of application and in order to computerize the process of inviting online applications and screening of applications at ASRB. The scorecards for RMP positions were finalized and accordingly RMP posts were advertised in the month of Nov, 2021. Applications for the above mentioned 90 RMP positions were invited online. The Board completed the recruitment process for five posts (Appendix V) of senior RMP positions till March, 2022 details of which are given in table below:



In all, the Board had screened 58 applications and called 32 candidates for interview of which 29 candidates actually attended the interview. As per rule, Board invites only top ten ranking candidates obtaining minimum qualifying marks in the scorecard evaluation for interview for each post. However, average number of candidates called for interview for each post is around 6.4.




Details of direct selection for RMP positions


Major disciplines wise breakup of proposals assessed

As per outcome of assessments, 89.75% (including 5.13 % deferred promotion) candidates got promotion to the next higher grade.




Assessment of Senior Scientists to the grade of Principal Scientists under Carrier Advancement Scheme (CAS)

The Board finalized and notified nomination of experts for 73 institutes including ICAR Hqrs. for constitution of 95 Departmental Promotion Committees (DPCs)





Revision of Application Form for RMP

Online application forms for direct recruitment have been revised in consonance with revised scorecard and the applications were made applicable from Advt. No. 01/2021. Web based application software has been developed to apply online and for screening of applications as per the revised scorecard. The application software is named as OASIS (Online Application & Scorecard Information System) and can be accessed online on URLhttps://asrbapplication.in.

Important features of OASIS are:

1. Home Page

- Online application system can be accessed through URL: https://asrbapplication.in
- Home page provides access to the application software.
- A new user has to first register himself/ herself by clicking on "New Registration" for creating a Login ID.

- Enter valid Email-Id and valid Mobile number for registration.
- You will receive an OTP on your registered Email and Mobile number.

- A new Registration Page will be displayed.
- Fill all basic information as required in the Registration Page.
- Set a password for your account.
- Upload photo and signature and click on "**Register**".
- After registration you will get the notification on your Email and mobile number that you have successfully registered and will receive the login credentials.

Implementation of Right to Information Act & Centralized Public Grievance Redress and Monitoring System (CPGRAMS)

Right to Information Act - 2005

As per Govt. of India guidelines, ASRB is committed to maintain complete transparency in examinations, recruitments, assessments and selection process and to implement Right to Information Act, 2005 in letter and spirit. In accordance with section 4 of the RTI Act 2005, up to date information pertaining to recruitment and assessment has been made available on ASRB website (www.asrb.org.in) from time to time.

The Board efficiently and satisfactorily responded to various requests and appeals under RTI Act within the stipulated time period as per provisions of the Act. Being a responsible "Public Authority", the Board has taken due and appropriate action in this regard. The Board has appointed three Central Public Information Officers (CPIO) and two Appellate Authorities for systematically handling there quests and appeals received from information seekers. During the period, the Board received 523 cases, mainly concerning the following:

Information sought

- Disclosure of names of experts.
- Bio-data of called candidates in interview for senior scientific positions.
- Marks secured in the screening and interviews.

- Procedure for screening of applications for direct recruitment posts.
- Marks given by the assessment committee.

- Answer Key of examinations.
- Photocopy of answer sheets, OMR sheets and question papers.
- Question papers of previous examinations.
- Proactive orders/decisions of the Board and implementation of Section 4 of the RTI Act in the Board.
- Details of outsourced manpower.
- Information regarding various tenders awarded by the Board.
- Information regarding Administrative Officer and Finance & Accounts Officer Examination - 2021.

Out of 523 cases, only 11.47% applicants filed first appeal. These cases were also disposed off successfully to the satisfaction of all concerned and the replies furnished by the Board. Complete details of the cases areas follow:



Centralized Public Grievance Redress and Monitoring System (CPGRAMS)

Board received 82 grievances during the period, most of the queries asked by applicants were related to the recruitment through various examinations namely LDC Examination-2017, NET/ARS/STO Examination-2021, AO & FAO-2021 and general information related to direct recruitment/ lateral entry. The Board disposed of all grievances satisfactorily.



Details of grievances during the year 2021-22



During the year 2021-22, ASRB ensured compliance of provisions of the Official Language Act, 1963. Board is committed to promote progressive use of Hindi in its office to fulfil targets fixed in the annual official language programme 2021-22 as per the Official Language Policy of Department of Official Language, Ministry of Home Affairs, Govt. of India. The Board also ensured that bilingual requirement of circulars, reports, question papers and other documents, as per provisions of the Act and Rules, are meticulously complied with.

- Nearly hundred percent of officers and staff working in the Board have working knowledge of Hindi.
- Helping literature, such as Agriculture Glossary, Specimen of standard letters/ drafts in Hindi, Hindi equivalents of common sentences etc. have been made available to the staff.
- Hindi version of examination rules, notices, and syllabi, instructions to candidates, admission certificates, test booklets, answer sheets, question papers, application forms, attendance sheets and attendance lists were printed along with the English version.
- During the year one advertisement issued by the Board was published both in Hindi and English language in leading

newspapers of the country including 'Rozgar Samachar'.

- All computer keyboards in the office have letters in Devanagari script.
- English Hindi dictionary of important technical terms used in agricultural education/ research has been prepared for the benefit of paper setters/ translators.
- Candidates can use option of Hindi as medium in all competitive examinations as well as for answering questions in interview at the Board.
- ASRB website www.asrb.org.in is bilingual (English and Hindi).

Quarterly meetings of Official Language Implementation Committee (OLIC)

ASRB regularly conducted quarterly meetings of Official Language Implementation Committee (OLIC) under Chairmanship of Chairman, ASRB who is Nodal Officer for implementation of Official Language Policy in the Board. Four meetings of OLIC were organized in June, September, December, 2021 and March, 2022.Various issues pertaining to implementation of Official Language were discussed and decisions were taken in these meetings. 

Women Empowerment

National Eligibility Test

NET examination results over the past decade shows that percentage of qualified women candidates in the NET examination has increased multifold. NET certificate is awarded to the qualified candidates for eligibility to apply for positions of Lecturers/ Assistant Professors in State Agricultural Universities (SAUs) and other general universities with Agricultural Faculty.

Agricultural Research Service (ARS) Examination

Interest of women candidates has increased at entry level of Agricultural Research Service (ARS) and the percentage of selected women candidates in ARS examinations during the last five years has progressively increased from 31 to 43%. The Board has been making all possible efforts to encourage women candidates to compete so as to improve gender balance in the system in keeping with the spirit of gender equality and women empowerment.


