DEBARMENT NOTICE

As per para 5 (xxv) of the ASRB's Notification No. 1(2)/2020-Exam.II dated 30.03.2021, if a candidate resorts to improper means for obtaining admission to the examination, then in that case, he/ she shall be debarred permanently or for a specific period.

- In addition to the instructions contained in Notification No. 1(2)/2020-Exam.II dated 30.03.2021, clear instructions were mentioned in the Admission Certificate also, which reads as under:
- "Candidates should ensure that they appear for only one discipline during the entire examination cycle. In case they appear for more than one discipline, their candidature for the whole examination process will be cancelled."
- In the recently held CBT for NET-2021, ARS-2021 (Preliminary) and STO (T-6) Examination-2021 from 23.08.2021 to 27.08.2021 on all India basis, it has been observed that following candidates had filled multiple applications and also appeared in different disciplines for the said examination by manipulating minor changes in their name, father's name or other particulars:
