
2 ASRB – Background

2.1 Introduction

The Agricultural Scientists Recruitment Board (ASRB) was established on 1 November 1973. ASRB is an independent recruitment agency financed by Indian Council of Agricultural Research (ICAR) under Department of Agricultural Research and Education (DARE), Ministry of Agriculture, Government of India. The ASRB/ICAR has its headquarters at New Delhi.

Agricultural Scientists Recruitment Board (ASRB) is a premier recruitment agency for recruitment to scientific and other posts in the Agricultural Research Service (ARS) of the ICAR and to such other posts and services that the President, ICAR, may specify from time to time.

3 OVERVIEW OF THE EXISTING ONLINE FACILITY

3.1 Present Scenario of Online Examination Facility Of ASRB

ASRB has established its own Online Examination facility at 23 centres across the country and it became operational in 2014. The details of Locations of 23 Online Centres are given in Chapter 4. The Location wise details of Equipments are given in Chapter 5.

ASRB is presently conducting National Eligibility Test (NET), being eligibility condition for recruitment of Assistant Professor/Lecturer in State Agricultural Universities (SAUs) as well as Central Agricultural Universities (CAUs), twice in a year, and ARS preliminary examination (alongwith one of NET Exams) followed by ARS main examination once a year for recruitment of scientists in ICAR. Both NET and ARS (Preliminary) exams are being conducted in 56 disciplines of Agricultural & Allied sciences. ASRB has taken a lead in transforming from pen and paper mode examination to computer based test for NET and ARS (Preliminary) examinations, with the objectives of efficiency, accuracy, fairness and to improve the overall quality of examination system.

Software modules have been developed/ customized as per the requirement of ASRB for submission of online applications, payment of fees, generating and downloading admit cards, test administration, result declaration for NET & ARS examinations. The entire examination system has been audited by the third party auditors to ensure the quality and security of the system. The nodal officers and technical staff of the examination centers have been trained on the process of online examination through appropriate training programs. The first complete online examination was conducted successfully for NET-2014(1). A total of 18245 candidates applied online for the NET-2014(1), out of which 14178 (77.7%) candidates actually appeared in the online examination.

This examination was the first complete transformation from on-site penpaper mode examination to online examination. Thereafter, NET Exams were held in 2015, 2016 and the latest in May 2017, when 48000 candidates applied for it. The national facility created under the project for conducting online examinations has been tested successfully by conducting these online examinations for NET. It was also used by ASRB for conduct of Assistant Grade (preliminary) Exam for more than 50000 registered candidates. The Operation, maintenance and conduct of the examination was being done by the agency which established this facility.

Consequent upon completion of the agreement with the concerned agency, ASRB now intend to appoint an agency which may, inter alia, provide the following service to ASRB:

- i) To maintain the Data Centre (DC) established at ASRB Headquarters in Krishi Anusandhan Bhawan I (KAB-I), PUSA, New Delhi and the Data Recovery centre at IARI, Pusa Campus, just 200 mtrs from KAB-I.
- ii) To conduct the Online exam for NET and ARS(P) as well as other Exams of some of ICAR Institutes, as may be decided by ASRB, at 23 Nodal Centers across the country, including automated online registration, validation, hall ticketing, allocation of centers, and result declaration process.
- iii) To provide requisite software, with full security as well as Technical personnel support for maintaining the facility as well as for conduct of exams.
- iv) To ultimately provide support for optimal use of National Facility for online examinations for use of not only by ASRB, but also by ICAR Institutes and other sister organizations for other examinations.


The DC is well equipped with state of the art hardware and software, including a number of servers, SAN storage, tape library, latest application and system software to control the activities of online examination. A dedicated Internet leased line (1:1) of 4 Mbps for Internet connectivity is provided in DC to connect with examination centers. The Data Center is fully secured through Internet Firewall (Checkpoint) and Network Intrusion Prevention System (Radware) appliances deployed in the Data Center Network, and also with Host Intrusion Prevention System (Trend Micro) software deployed on all Servers. The DR site has been created in the IARI campus and is well equipped with necessary equipment. The DC and DR sites have been connected through a dedicated wireless link of 10 Mbps for data backup. The service provider agency shall also provide Security and Internet support for these.

The examination centers are connected with DC through high speed broadband connectivity through BSNL/MTNL network, except at DMAPR, Anand where the connectivity has been provided through a private ISP due to non-availability of the BSNL network. The application software modules for online registration of applications, payment of examination fees through integrated online payment gateway, allocation of examination centers/slots, generating and downloading of admit cards, and declaration of results have been developed and customized as per the needs of ASRB. Test administration software, has also been customized for NET/ARS examinations. These applications software modules have been developed using ASP.NET and VB.NET on the framework 4.0 - Visual studio 2010. Databases have been designed and developed using SQL server – 2012.

The entire system was audited for:

- 1. Asset and Acceptance audit of hardware;
- 2. Application Software Audit;
- 3. Information System Security Audit.

The management structure and functioning of online examination network system consisting of NOEC and 23 examination centers is depicted through the following diagram:



3.2 Need for this tender

These facilities are presently used by ASRB for 20-30 days in a year. ASRB would like to optimally use the facilities round the year, though it has no intention to commercialize the same. As mentioned above, the facility was primarily created for the conduct of online examinations for NET/ARS (Preliminary) Examination at ASRB HQ and 23 examination centers but it may also be used for conducting any other computer based test by ASRB/ICAR or any other sister Govt. agencies. The modalities of engaging a service provider for conducting such examinations are being explored and this RFP is a step in that direction to select System Integrator to operate and manage this online examination system to provide services in conducting examination and outsourcing the examination centers to sister Govt. organization and ICAR Institutes for conduct of examinations for external agencies on revenue sharing basis with ASRB, if so required by ASRB.

3.3 PROPOSED MODULES FOR OPERATION & MAINTENANCE OF THE FACILITY

The Agricultural Scientists Recruitment Board (ASRB), therefore, plan to appoint an Agency for operation and maintenance of the current infrastructure including Data Center, Disaster recovery center, etc. established under its National Online Exam Centre (NOEC) scheme and to conduct online examination using this infrastructure.

ASRB is looking to Bid separate Module wise as under:

Module - I: (PRICE PER REGISERED CANDIDATE)

- i) <u>Maintenance and Operation of ASRB Data Center and Disaster Recovery</u> Center at Delhi for Three Years.
- ii) Conducting Online Examination using ASRB DC & DR at 23 Nodal Centres for three years
- iii) Providing of additional centres by the agency if the capacity of ASRB 23 centres is found insufficient to accommodate the no. of applicants for an Examination during the same period.

Module II: (PRICE PER REGISTERED CANDIDATE)

- i) <u>Maintenance of ASRB Data Center and Disaster Recovery Center at Delhi</u> for Three Years.
- ii) Maintenance of all hardware of 23 Nodal Centers across the country for Three Years
- iii) Conducting Online Examination using ASRB DC & DR at 23 Nodal Centres for three years
- iv) Providing of additional centres by the agency if the capacity of ICAR 23 centres is found insufficient to accommodate the no. of applicants during same period

Module III: (LUMPSUM AMOUNT FOR I & ii AND PER REGISTERED-CANDIDATE FOR (iii) & (iv))

- i) <u>Maintenance of ASRB Data Center and Disaster Recovery Center at Delhi</u> for Three Years (lumpsum amount to be indicated)
- ii) Maintenance of all 23 Nodal Centers hardware across the country for Three Years (lumpsum amount to be indicated after indicating maintenance for each individual centre)
- iii) Conducting Online Examination using ASRB DC & DR at 23 Nodal Centres (per registered candidate)
- iv) Providing of additional centres by the agency if the capacity of ICAR 23 centres is found insufficient to accommodate the no. of applicants (per registered candidate)

NB: <u>The most optimal and economical module of Maintenance & Operation</u> will be selected by the ASRB after receipt of Bids

3.4 MODULE WISE SCOPE OF SERVICES -

MODULE - I

- i) Maintainance & Operation of ASRB Data Center (NOEC) established at ASRB Headquarters, New Delhi and Disaster Recovery Center established at IARI, New Delhi.
 - Maintaining all hardware and software including internet installed at NOEC and DR site at Krishi Anusandhaan Bhawan – I, New Delhi and IARI, Pusa, New Delhi-110012. Details of the hardware/software etc. are given under para 5.1 and 5.2
 - Maintenance will be all inclusive, including replacement of spare parts, consumables, repairs, servicing etc. required to keep the equipment/peripherals into fully functional mode.
 - Bidder is responsible for Data Centre Data Recovery(DC-DR) connectivity, its security and Internet support.
 - To address all security issues- Providing security software and securing the NOEC and network systems for a highly secured and sanitized system for the entire process. Providing firewall, anti-hacking and antivirus, anti-adware, anti-Trojans and Malware software.
 - Selected Bidder should establish a technical helpdesk at data Center on all working days from 09:00 a.m. – 06:00 p.m. on all working days and for 24 hrs on all days when Exam is scheduled.
 - All the licenses will be procured in the name of The ASRB.
 - All the licenses shall be owned by ASRB even after the contract period.
 - Warranty on all software for entire contract period.
 - Provide a database backup and recovery plan that will be tested for adequacy
 - All software products must be with Advanced Technical Support (ATS) for entire period of contract during which all upgrades, updates and patches of offered software should be provided without any extra cost to ASRB.
 - Availability of one qualified person (Hardware) to manage the helpdesk & day to day affairs of DC & DR at NOEC throughout the year.

ii) Conducting Online Examination using infrastructure of DC & DR at ASRB & 23 Nodal Centers

- The agency will be required to provide online connectivity and to ensure uninterrupted backup arrangement to support the conduct of Examination smoothly at the 23 online centres of ASRB.
- Online registration of applications, managing online payment of fee, generation of e-admit cards, sending SMS and e-mail to registered candidates for downloading of e-admission certificate as well as any other update relating to Examination.

- Live testing/mock test exercise at each centre two days in advance of the scheduled exam to ensure hassle free conduct of Exams. All discrepancies noticed during such mock drill to be rectified at least 24 hrs before the start of Online Examination.
- Last three year record says, approx. 50000 candidate appearing per Year, at an average. This is for calculation purpose only. Figure may increase/decrease.
- Selected vendor will develop or customize the online examination application forms.
- Providing sufficient staff with adequate technical experience for developing application software & conduct of examination.
- Providing hand held detectors to frisk/check the candidates so that they do not carry any electronics and banned items inside the Examination centre.
- Training of ASRB users and IT staff in the use and maintenance of the application software and related products
- Taking care of uploading, verifying, validating etc. of the data received from candidates.
- The Agency should also take care of uploading, verifying, validating, etc. the data from Test Centers.
- The Agency will also be responsible for creating unique identifications/codes that will be required in the application system in consultation with ASRB.
- Customize and install packaged software for an application, if available. The packaged solution should have a proven track record of at least 3 years in large examination environment with at least 20, 000 users.
- o Provide a database backup and recovery plan that will be tested for adequacy



Following shall be kept in view while evaluating the Technical Bid:

8.3.1. A. Experience

The total number of projects to be considered for evaluation under this criterion shall not exceed 10 and the date of completion of project should lie between 01.04.2012 to 31.03.2017. Bidder should include such projects which involved similar nature of work as of this RFP, have high project value with more number of locations and higher number of users so as to score high marks. Marks shall be awarded only for projects of similar nature as per this RFP. - (i) Bidder will be awarded marks on the basis of number of years of their existence in the IT implementation business.
- (ii) Bidder will be awarded marks on the basis of their average turnover from IT Implementation operations during the latest available three years ending 31st March,

2017. In case the published annual reports do not explicitly indicate the turnover of "IT Implementation" segment, the annual report should be accompanied by a certificate from practicing Chartered Accountant confirming turnover from IT Implementation operations.

8.3.1.C. Curriculum Vitae

- i) Bidder will be awarded marks on the basis of the Qualification of the five resources to be deployed for the longest period during Maintenance and Operation of ASRB online system). The core team of 05 resources/persons must include at least one team leader, one security expert and one Hardware maintenance engineer.
- ii) Bidder will be awarded marks on the basis of the experience of the five resources to be deployed for the longest period during project Maintenance and Operation). Sum of scores for individual CVs (up to a maximum of five) will be the final score for this criterion. The core Team of 05 must include at least one team leader, one security expert and one hardware maintenance engineer.

8.4 Stage Four: Commercial Bid Evaluation

Part –D of the bid will be opened only of those bidders who qualify in the Technical evaluation. Such bidders will be informed about the date and time of the commercial bid opening.

The procedure for evaluation of the Commercial Bid will be as follows:

- Explanation for Module-I: For evaluating the Financial Bid for Module-I, the total of Prices A(i), and A(ii) will be considered and multiplied with 30,000(approx. number of candidates). Thereafter price of B shall be multiplied with 20,000. The total of 'A' and 'B' will thereafter be divided by 50,000 to calculate the average price and L-1 will be arrived accordingly.
- Explanation for Module-II: Similarly for module-II, the rate quoted for A(i) (ii) & (iii) shall be multiplied by 30,000 and that of (B) by 20,000. The sum of the two so arrived will be divided by 50,000 to calculate average price and L-1 will be decided accordingly.
- Explanation for Module-III: The lumpsump rate is required to be quoted for A(i) A(ii) and A(iii). In this lumpsump amount, the rate quoted for B will be added, after multiplying the same with 20,000. The lumpsump so arrived will be compared to calculate the L-1.
- **8.4.1** Provided the Technical Bid is found to be qualified, ASRB will correct arithmetical errors during evaluation of Financial Bid on the following basis:
 - If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of ASRB there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected;

- II. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- III. If there is a discrepancy between words and figures, the amount in words shall prevail. However, where the amount expressed in words does not represent arithmetically correct total, the amount in figures shall prevail subject to (i) and (ii) above.
- IV. Except as provided in sub-clauses (i) to (iii) herein above, ASRB shall reject the Financial Bid if the same contains any other computational or arithmetic discrepancy or error.

If the Bidder who submitted the lowest evaluated Bid does not accept the correction of errors, its Bid shall be disqualified and its Bid Security shall be forfeited.

8.5 Award of Contract

8.5.1 Award Criteria

ASRB shall award the Contract to the Technically Qualified Bidder who is L1 i.e. who has quoted the lowest total Cost (In case of tie, the bidder with higher technical score will be awarded the Contract).

8.5.2 Notification and Acceptance of Award

ASRB, prior to the expiration of the period of bid validity, shall issue Letter of Intent (LOI) to the successful bidder to notify it of acceptance of Bid. The Bidder shall send acknowledgment and acceptance of LOI within 7 days.

Until a formal Contract is prepared and executed, the notification and acceptance of Award shall constitute a binding Contract between ASRB and the successful bidder.

8.5.3 Furnishing Performance Security and Signing of Contract

The successful bidder shall, within fifteen (15) days of the issue of LOI, provide an irrevocable Performance Bank Guarantee (PBG) equivalent to 10 percent of the Contract Price in favour of 'Secretary, Agricultural Scientists Recruitment Board' in the format prescribed in this RFP as **Section 9.1** from a Nationalized/Scheduled Bank valid till the expiry of the Contract.

Failure of the successful Bidder to submit the Performance Security within the permitted time period shall constitute sufficient ground for the annulment of the award and forfeiture of the Bid Security. In that event, ASRB may either award the work to the next higher Bidder(s) or call for new bids.

After the Performance Security is received by ASRB, it will enter into a formal Contract with the successful bidder detailing obligations of both the parties.

The selected bidder will be required to provide additional PBG at the time of payments at different stages as may be mentioned in payment terms. These

guarantees shall remain valid till expiry of 3 months from the date of completion of the contract.

8.6 Preparation of Crisis Management Plan (CMP)

The Selected Bidder is required to prepare a crisis management plan and periodically review along with designated ASRB team at mutually agreed intervals and update the document, if required.

The Selected Bidder shall provide a plan for handling crisis situations like DC disruption/ failure, DC service provider business disruption, Bandwidth service provider business disruption, natural disaster etc. and update the same periodically.

8.7 Exit Plan

The Exit Plan should cover, among others, the following:

- All documents which will be needed to be executed to effectively transfer the ownership and title, including OEM warranties (AMC/ATS) in respect of all equipment/software etc.;
- All related documentation and other configurable items etc., if any, in the possession of the Selected Bidder;
- List of all IT Assets, passwords, etc. at all locations;
- Plans for handing over management of DC, Applications and other resources to ASRB or agency nominated by ASRB.
- Strategy for continuity of services in the event of an occurrence like DC service provider going out of business or is bought out etc.

ASRB will review the Exit plan periodically at mutually agreed intervals.

In the event of termination or expiry of the Contract, both Selected Bidder and ASRB shall comply with the provisions of Exit Plan.

During the exit management period, the Selected Bidder shall use its best efforts to continue delivery of all regular services. In addition, the Selected Bidder shall ensure the following:

- Three months of support to replacing Service Provider and/or ASRB after termination or expiry of the Contract.
- Complete handover of the processes, products, software, licenses, source codes, reports, documents, manuals, data, web content and other Intellectual Property Rights to the replacing Service Provider and/or ASRB.
- Complete handover of all hardware components installed at ASRB locations and Data Centre in fully functional state along with AMCs / warranties for the unexpired term of the Contract.
- Certificate of Acceptance from authorized representative of replacing Service Provider / ASRB issued to the Selected Bidder on successful completion of handover and knowledge transfer.

10 Performance Levels and Penalty Provisions

10.1 Purpose

This Section defines the levels of service to be provided by Selected Bidder to ASRB for the duration of this contract. For this purpose, a number of parameters have been set along with desired performance levels and penalties that would be levied in case of non-achievement of desired performance levels.

10.2 Description of Service Provided

The Selected Bidder will provide maintenance and operation support as per details given in Module wise **Scope of Work**. To ensure adherence to the above, performance levels have been defined for the service window mentioned in **Section 10.4**.

10.3 Duration

This Performance Levels and Penalty Provisions would be valid for the entire Contract Period. The Performance Levels and Penalty Provisions may be reviewed and revised according to the need of ASRB.

10.4 Required Service Window

The timings during which the Performance Levels and Penalty Provisions will be applicable are given in the table below:

Uptime within the specified service window shall be calculated on monthly basis as under

"Scheduled Downtime" means the aggregate number of hours in any month during which each service is down due to preventive maintenance, scheduled maintenance, or any other situation which is not attributable to Selected Bidder (including their suppliers, subcontractors, service providers, etc.). Any scheduled downtime will be undertaken with prior approval and consent of ASRB and shall not overrun into prime hours. The scheduled downtime would be added to the downtime if it runs into prime hours. Any outage of system which is not scheduled and approved by ASRB will be considered as downtime.

Planned downtime for the preventive maintenance (as part of scheduled downtime) shall not exceed 04 hours in a month.

The communications for scheduled time shall be sent to ASRB at least 48 hours in advance except in emergency cases where a shorter notice may be given. Services relating to security and backup outside business hours may be provided remotely.

10.5 <u>Performance Parameters</u>

Performance Levels have been defined for the following:

- Application Availability
- Application Performance
- Security Services
- Manpower Availability for Support

- Backup
- Incident Management & Helpdesk Services

10.5.1 Application Availability

The Selected Bidder will be responsible to ensure continuous availability of all applications and related services to the ASRB users located at HQ and Branches by ensuring the availability of services including, but not limited to, the following:

Applications and databases

The Selected Bidder shall ensure that availability of the applications to users is monitored in real-time through implementation of a suitable Enterprise Management System (EMS) of the agency, and the uptime is reported on monthly basis separately for each application at each location (Projects and Units). The EMS system should also be able to monitor end users experience on real time basis so as to capture data in case of any degradation or disruption of service. The EMS system should also provide data for problem identification and root cause analysis in addition to generation of reports to meet requirements. All performance levels will be applicable and monitored for all the applications and devices which are part of the solution implemented by the Selected Bidder.

The Selected Bidder will use Enterprise Management System (EMS) / Network Management System (NMS) of the data center service provider as a service. The EMS/NMS should, inter-alia, meet the following requirements:

- Real Time Health Management Services (For Servers)
- Server and Operating System Monitoring.
- Database Management Services.
- Historical Performance Trending of Servers & Applications.
- Software/ Patch Distribution Services.
- Inventory for Hardware and Software to be collected automatically (Servers & Desktops).
- Event Correlation and Event Management Services.
- Complete Management of DC and ASRB LAN at all offices and its integrated Modules configured in various switches offered for Core, Distribution and Access Layer.
- Managing the DC, ASRB Offices LAN and WAN routed Traffic.
- Recognize common network problem, management of multi-vendor network with discovery, mapping and alarm tracking.
- Network analysis for switch fabric/CPUs, monitor utilization of switch resources & in isolating the network problems, provide performance monitoring, trouble shooting, capacity planning, and report generating of various statistics.

EMS/NMS shall also integrate events to automatically create trouble tickets in helpdesk system for better and in time problem resolution.

Penalties as per the following levels will be applicable in case of lower than defined level of availability of the services:

10.5.2 Application Performance

The solution is expected to provide an efficient performance throughout the contract period in terms of response time for the applications. This performance shall be measured at the user end for each location of ASRB.

The Selected Bidder is required to meet the defined performance levels; the number of transactions and users may vary at different points of time during the contract period.

With 70% users loaded on to the system, the response times should not exceed the limits stated in the first column of the table given below. Penalty levels will be decided based upon the percentage of transactions that are not completed within expected response times as per the scales given in the following table:

Highest Penalty Level recorded in respect of any of the above sub-parameters out of the eight line items defined above will determine the penalty level for a location. However, Penalty Level 6 will become applicable in case over 5% of transactions (covering all applications) in a month require a response time of ten times or higher compared to the above given desired response time in respect of any single sub-

parameter. The weighted average of the penalty levels of various locations shall the be worked out.

10.5.3 Security Services

Security threatening incidents will include but will not be limited to the following:

- Virus Attack: This shall include malicious code infection on any of the servers or computers within the ASRB network (including all locations of ASRB and Data Centre) or unchecked virus infected mails passing through the other applications.
- Denial of Service Attack: This shall include non-availability of service (Any one or more applications).
- Intrusion: Unauthorized access to ASRB information system, resulting in loss of confidentiality/integrity/availability of data or web content or data theft or data damage.

All security threatening incidents, whether or not leading to disruption in services, would attract penalty as given below:

The selected bidder shall prepare security policies in consultation with ASRB to restrict malicious websites and internet access to users. The selected bidder shall provide enterprise grade antivirus application capable of managing desktop clients and safeguarding systems from any virus infected external media.

10.5.4 Manpower Availability for Handholding and Support

The Selected Bidder shall ensure availability of manpower as indicated in the Bid or otherwise agreed with ASRB. Non-availability of manpower will lead to penalties as per scales given below:

The backups shall be scheduled to ensure that the data should be restorable to a state within the past 12 hours. Archival and retention policies shall be finalized in consultation with ASRB at the time of implementation before UAT. The selected bidder shall also provision safety vault services for offsite storage of the cartridges; an electronic notification (email and SMS) should be sent to authorize ASRB official for all access events.

The selected bidder shall provide 18 Media Cartridge and 2 Cleaning cartridges along with Tape Library. Apart from the 10 media cartridges, ASRB shall procure media cartridges as and when required.

10.5.6 Incident Management

All service requests to helpdesk will be classified and assigned a Severity Level. Severity Levels are set at 1, 2, 3, 4 or 5 depending on the nature of the problem. The criteria for classification into Severity Levels will be mutually agreed upon between the Selected Bidder and ASRB and may be jointly revised if situation so warrants. The basis for classification into these levels is indicated below:

Severity Level 1: A problem affecting production service for large number of users (e.g. – network problems, server problems, network printer problems, virus problems on servers, etc.) or involving business critical applications or services.

Severity Level 2: A problem that has a significant impact on one or more users (e.g. – problem in logging on to network, virus problem on desktops / laptops, workgroup application outage, time critical single user problem or request, database replication failure, printing problem, etc.)

Severity Level 3: Non-critical single user impact. (e.g. - restricted functionality, usage inquiry, installation of desktops, routine request for LAN administration, change in configuration, etc.)

Severity Level 4: Information, Training, Minor Errors

Severity Level 5: Enhancement Requests

MTTA: Mean time to attend. This parameter would refer to the mean time from logging of the service request to response by the helpdesk.

MTTR: Mean time to repair/resolve. This parameter would refer to the mean time from logging of the service request to its successful resolution and closure.

The Selected Bidder shall notify ASRB about the problem resolution within 30 minutes of final resolution of the problem.

10.6 Reporting

The Performance Levels shall be monitored and reported on a weekly as well as monthly basis.

The Selected Bidder shall submit following reports, along with all supporting information directly from Enterprise Management System and or performance measurement tools, for various performance levels:

- Number and Percentages of service targets met
- Number and severity of service breaches
- Number of services with timely reports and current services reviews
- Improvements in user satisfaction (Quarterly)

The Selected Bidder is expected to provision all the relevant modules of the EMS/NMS as well as any other applications required for the creation of automated reports which shall be required to monitor the performance levels. The reports will include "actual versus target" performance, a variance analysis and discussion of

appropriate issues or significant events. ASRB shall have direct access to this system to generate reports on its own.

The Selected Bidder will make available monthly performance reports in an agreed upon format by the 5thday of subsequent month. No payments shall be made to the Selected Bidder unless the reports are submitted to ASRB.

10.7 Penalties

Penalties will be imposed for not meeting performance levels in respect of each parameter as indicated below:

In respect of performance parameters "Security Services", the penalties are indicated in **Section 10.5.3** itself.

The weighted average of the penalty levels of different locations as required in **Section 10.5.4** shall be worked out in the ratio of number of front end computers and shall be rounded to the whole number on the higher side. However, if penalty level 6 is incurred at any single location at ASRB, then the penalty level 6 shall be applicable for that performance parameter, irrespective of the weighted average. In case an incident affects multiple performance parameters then it shall result in penalties for all the performance parameters violated. For example, if the ICT applications are not available due to a virus attack, then all the following performance parameters will be affected and invite penalties:

- Application Availability
- Incident Management & Helpdesk Services
- Security Services

In case a particular parameter attracts penalty level 5 in more than three months in one year, or penalty level 6 in any month, ASRB shall have the right to get the same or related service(s) from any other source at the cost and risk of the Selected Bidder.

Penalties applicable in respect of different parameters shall be added to arrive at total penalty liable for the month.

The penalty shall be calculated on the applicable monthly charges which shall be equal to 1/3 of the quarterly amount payable for the maintenance and support services. For example, if the SI has incurred penalties of 5%, 3% and 4% as per the measurement of the performance levels during three months over a quarter, each penalty will be applicable to 1/3 of the total quarterly amount payable.

10.8 Monitoring and Auditing

- ASRB will review the performance of Selected Bidder against the Performance Levels each month, or at any periodicity decided by ASRB. The review / audit report will form basis of any action relating to imposing penalty or breach of the Contract. Any such review / audit can be scheduled or unscheduled.
