### **Terms and Conditions**

- 1. The sealed quotations superscribed with name of contract i.e. "Quotations for procurement & installation of CCTV cameras" may be addressed to Secretary, ASRB, KAB-I, Room No.101, Pusa, New Delhi-110012 which should reach in this office by 3.00 p.m. on 10.06.2016. It will be opened on the same day at 3.30 p.m.
- 2. Quotation received after the stipulated date and time/ incomplete quotations/ unsigned quotations will not be entertained. The interested representatives of the tenderers may be present, if so desire, during the opening of the tender by the committee.
- 3. Before quoting the rates, the locations for installation of CCTV cameras may be inspected/ checked during the office hours in the premises of the Board. Some CCTV cameras are already installed in the Board premises. The additional units shall strengthen the existing monitoring system, hence there should be complete synthesis and co-relation in functioning of all existing as well as new cameras.
- 4. An amount of ₹5,000/- towards earnest money in form of Demand Draft drawn in favour of Secretary, ASRB has to be sent alongwith the bid. The quotation received without earnest money shall be summarily rejected. The earnest money will be refunded to the tenderers only after contract for supply & installation of said CCTV Cameras has been awarded to the successful firm. No interest will be payable on earnest money.
- 5. The competent authority in the Board shall have the right to reject all or any of the offers.
- 6. Mere quoting lowest rates will not amount to commitment for award of contract.
- 7. Only such firm may apply who have experience of handling at least three similar contracts for providing & installing CCTV Cameras in Govt. Organizations. Certificates to that effect (at least from three such organizations) should also be attached with the tender.
- 8. No advance payment in any case would be made. However payment will be made after successful installation & commissioning.
- 9. The specifications of the equipments to be supplied may be provided with the tender enquiry as an enclosure. A quote received against a tender enquiry shall be deemed to commit the Vendor to those specifications.
- 10. The specification contained in the tender enquiry may be modified if requisite specifications are not available, by mutual consent in written before the contract is accepted.
- 11. For all cameras, DVRs and other related hardware: In case of defects occurring to any component during the guaranty/warranty period, the component is to be replaced by the Vendor within 24 hours free of cost.
- 12. The firm whom the tender will be awarded, will have to deposit the performance security equal to 10% of the total amount till such time the period of guaranty/warranty expires. If the services are not found to be satisfactory, the performance security is liable to be forfeited. No interest will be paid on performance security.
- 13. If any dispute(s) arises between the Board and the firm with reference to the contract, the Board will decide it and its decision will be binding on the firm.
