Board finds that the candidate does not fulfil any of the prescribed eligibility conditions, his/her candidature is liable to be rejected. The candidates are also advised to go through the eligibility conditions as mentioned in the ASRB's Notification for ARS Examination-2015 [No. 14(1)/2015-Exam.I dated 09.10.2015]. If the candidates do not possess the required relevant documents/ certificates in support of their eligibility, they shall not be allowed to attend the viva-voce.
- The candidates are advised to regularly visit the ASRB's website i.e. www.asrb.org.in. All 4. the information/updates related to ARS Viva-voce will be uploaded on the above mentioned website only.
- The candidates are directed to bring the attested copies as well as original 5. documents/certificates on the day of viva-voce. The list of documents/ certificates has been indicated in the exam notification under "Important Instructions for Candidates".
- Candidate will not be allowed to appear in the viva-voce if he/she fails to produce any/all of 6. the original documents/certificates. Also, he/she will not be given any extension in time for submission of any/all of the documents/certificates.
