<u>ADMINISTRATIVE OFFICER (AO) AND FINANCE & ACCOUNTS OFFICER</u> (F&AO) WRITTEN EXAMINATION – 2014 HELD ON 23.11.2014.

On the basis of the Result of the Competitive Examination for recruitment to the posts of Administrative Officer (AO) and Finance & Accounts Officer (F&AO) at ICAR Research Institutes - 2014 conducted by Agricultural Scientists Recruitment Board (ASRB) on 23.11.2014, the list of candidates qualified for Structured Interview/ Personality Test for the posts of AO and F&AO is annexed as **Annexure-I** and **Annexure-II** respectively.

- 2. The Structured Interview/Personality Test for these candidates has been scheduled during **3-12 February**, **2016** as per dates mentioned against each to be held in the office of ASRB at Krishi Anusandhan Bhawan I, Pusa, New Delhi 110012. The Interview call letters will be issued to the qualified candidates through e-mail on their e-mail address given in the application latest by 18.01.2016. Besides, SMS will also be sent on their registered mobile number. If any candidate fails to receive the interview call through e-mail 10 days prior to the date of his/her interview, he/she may contact the Examination-II Section, ASRB on phone no. 011-25848172 and 25840251 Extension 202 (10 am to 5 pm on all working days) or e-mail to soexam2@asrb.org.in. *No paper Interview letter will be issued for the interview by the Board*.
- 3. Qualified candidates are required to submit self-attested photocopies of requisite documents/certificates in support of their eligibility to Controller of Examinations, Agricultural Scientists Recruitment Board, Krishi Anusandhan Bhawan-I, Pusa, New Delhi-110012. The list of documents/certificates required to be submitted can be downloaded from the link given below. Closing date for receipt of the aforesaid documents in ASRB is 14.01.2016 failing which the interview call e-mail will not be issued to such candidates.
- 4. The candidature of the qualified candidates is provisional subject to their being found eligible in all respects. The candidates will be required to produce the original certificates in support of their claims pertaining to Age, Educational Qualifications, Community, Person with Disability (PwD) and other documents such as Bio-Data Form and Attestation Form etc. at the time of their Structured Interview. The formats of SC/ST/OBC/PwD, Bio-Data Form, and Attestation Form etc. can be downloaded from the link given below. They are, therefore, advised to keep the aforesaid documents ready with them. Candidate will not be allowed to appear in the interview if he/she failed to produce any/all of the original documents/certificates. Also, he/she will not be given any extension in time for submission of any/all of the documents/certificates. The Board will not be responsible for any loss incurred to the candidates due to non adherence of these instructions.

- 5. No request for change in the date and time of the Structured Interview will be entertained.
- 6. The candidates are advised to notify changes in their address, if any, to the Board immediately through Fax or letters forthwith.
- 7. The marks scored by the candidates, who have not qualified, will be put on the Board's website within 15 days from the date of publication of the final result (after conducting Structured Interview) and will remain available on the website for period of 60 days.
- 8. The candidates who belong to Jat community of the States of Bihar, Gujrat, Haryana, Himachal Pradesh, Madhya Pradesh, Uttar Pradesh, Uttrakhand, NCT of Delhi and Bharatpur & Dholpur Districts of Rajasthan and who had applied under OBC category are informed that in view of the judgement of Hon'ble Supreme Court of India dated 17.03.2015 in WP(C) No. 274/2014 titled Ram Singh & others vs. Union of India, have been treated as General Category candidates and hence not entitled to the concessions available to OBC Category candidates.
- 9. The appearance of candidate in the interview will be purely provisional. If at any stage, it is found that the candidate do not fulfil any of the prescribed eligibility conditions, his/her candidature will be rejected. The candidates are therefore advised to go through the eligibility conditions as mentioned in the ASRB's Notification for Administrative Officer & Finance & Accounts Officer Examination-2014 No. 2(1)/2014-Exam.II dated 8th July, 2014. If the candidates do not possess the required relevant documents/ certificates in support of their eligibility, they need not come for the interview.
- 10. The candidates are advised to visit the ASRB's website i.e. www.asrb.org.in regularly. All the information/updates related to Interview including Interview Schedule will be uploaded on the above mentioned website only.
- 11. Candidature of some of the candidates has been rejected by the Board. The list of such candidates along with the reasons thereof has been given in **Annexure-III**.
- 12. While every care has been taken to ensure accuracy of the result, if at any stage, any discrepancy comes to the notice of ASRB, the Board reserves the right to rectify the same and no claim whatsoever will be entertained if any person/candidate is affected in the process.
