The contract so awarded, shall be extendable for a further period of 02 years, one year at a time, subject to satisfactory performance and mutual consent.

II. Terms and Conditions

A. General Terms & Conditions

- 1. On line bids are invited in **two Bid systems**, (1) Technical and (2) Financial. Both the bids shall be uploaded at CPP Portal. Off line bids shall be summarily rejected.
- Quotation should be complete in all respects and sent within specified date as mentioned on covering letter. The quotations received after the prescribed date shall not be considered.
- Correction or over-writing in the tender document is not permissible. Every sheet of the Tender document and the terms and conditions should be signed and stamped by the authorized signatory of the firm.
- Bidder shall not be banned / suspended / blacklisted by any Government /PSU / Corporate organisation or convicted in any court of law across India. Bidder to submit

- a self-declaration / undertaking, not older than 03 months, in prescribed format (as per annexure II) along with the bid.
- 5. The bidder is at liberty either to be present himself or authorize not more than one representative to be present at the opening of the tender. The representative attending the opening of the tender on behalf of the bidder should bring with him a letter of authority from the bidder and proof of identification. Also, the tender shall be opened at Room No. 101, Krishi Anusandhan Bhawan-I, Pusa Campus, New Delhi 110012.
- 6. The ASRB reserves the right to accept or reject any bids and to annul the bidding process and reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for the Purchaser's action.
- 7. The final acceptance of offer will rest with ASRB, who does not bind itself to accept the lowest bid and reserves the right to reject any or all the bids received, without assignment of any reason. All the bids in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
- An Office of the service provider must be located in the state of consignee, i.e. New Delhi/NCR. Documentary evidence, as specified, to be provided by the Bidder.
- 9. The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to submit an undertaking / bank solvency certificate, not older than 03 months, along with the bid.
- 10. Any failure on the part of the tenderer to observe the prescribed procedure and any attempt to canvass for the work will prejudice the tenderer's quotation. Conditional bids will not be accepted and shall be summarily rejected.
- 11. At any time, prior to the closing date of submission of bid, purchaser may, for any reason whether at its own initiative or in response to a clarification required by a prospective bidder, modify the tender documents by amendments.

B. Opening of Bids:

- 1. The Technical bid will be opened on pre-scheduled time, date and venue in the presence of the bidders' representatives if any, who choose to attend.
- 2. The bidders' representatives who will be present shall sign in the designated register evidencing their attendance. In the event of the specific bid opening being declared a holiday for the purchaser, the bid shall be opened at the same time and location on the next working day.
- The bidders' names, bid withdrawals, details of bid security and such other details as the ASRB at its discretion may consider appropriate will be announced at the time of bid opening.
- 4. The firms who have submitted the bids and whose offers are found technically suitable shall be informed of the opening date of i.e. "Price Bid "(Financial Bid)".

C. Evaluation of bids -

 Bids shall be evaluated on the basis of the information/documents furnished by the bidder. The conformity of the bids to the technical specifications and commercial terms and conditions shall be examined.

- 2. Responsiveness of the bid shall be determined based on the technical and financial capability of the bidder to execute the contract.
- 3. ASRB may contact and verify bidder's information, references and data submitted in the bid without further reference to bidders.
- ASRB reserves the right to use and interpret the bids as it may, in its discretion, consider appropriate, when selecting bidders for granting of the letter of intent/ notification of Award of contract.
- ASRB may waive off any minor infirmity or non-conformity or irregularity in a bid, which does not constitute a material deviation, provided such a waiving, does not prejudice or affect the relative ranking of any bidder.
- ASRB may seek clarification in writing from bidder by fax on any point, if so required.
 Bidder shall promptly reply by fax within the time limit specified in the clarification letter from ASRB.

D. Earnest Money Deposit -

 Bidders are required to submit a "bid security declaration", in place of EMD, accepting that if they withdrew or modify their bids during the period of validity etc., they will be suspended for a period of 03 years from participating in any tenders / contracts floated by the Board. Format for bid security declaration annexed as Annexure I.

E. Performance Security -

- The firm whom the contract will be awarded, will have to deposit an amount of Rs 36,000/- (Rupees thirty six thousand only) as performance security valid for 60 days from the period of contract expires.
- 2. No interest will be paid on performance security.
- 3. In case of violation of any terms and conditions on the part of the firm is noticed and/or the services are found unsatisfactory, performance security can be forfeited at the discretion of the Competent Authority in the Board.
- 4. In case, the successful bidder shows inability at any stage, after the contract is finalized and awarded, for whatsoever reason(s), to honour the contract, performance security deposited would be forfeited.
- Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft / FDR / Insurance surety bond in favour of/pledged to "Secretary, ASRB" payable at "New Delhi".

F. Extension Clause -

1. The contract shall be valid for a period of one year initially. However, the contract may be considered for extension by mutual consent and for two more years, one year at a time, as may be agreed upon subject to proper services provided by the firm, mutual consent and approval of the competent authority in the Board. A 10% increase in Price bid shall be given for every annual extension.

G. Consortium:

1. In case of contracts, wherein the seller alone does not have necessary expertise, the seller can form consortium with other sellers for submission of the bid, with one of the consortium company as the leader. However, each and every member of the consortium shall be equally responsible for the complete execution of the project contract. An undertaking to this effect is to be uploaded with the bid.

H. Financial Bid -

- Contract rates once finalized will not be enhanced during the currency of the contract. No advance payment in any case would be made.
- 2. The contract shall be awarded to the bidder quoting the least amount as per Financial bid, i.e. L-1 bidder.
- Supplier shall be entirely responsible for all taxes, duties, license fees, etc, incurred on providing the agreed service under this tender. No tax or duty will be payable by the ASRB separately.
- 4. If there is any enhancement in the taxes, duties, license fees etc, during the service period, the enhanced expenditure will be paid by the purchaser.
- In case of any changes in GST rate or any other statutory obligation resulting in the generation of extra profit by the service provider, the same has to be passed on to ASRB.

Payment Terms –

- The contract shall commence from the date as will be mentioned in the awarding letter and submission of performance security by the firm.
- 2. Payment shall be made on monthly basis and submission of duly signed delivery vouchers, satisfactory reports along with the bills.
- 3. GST Rates has to be stated separately in the Invoice generated by the firm and relevant notification or any other proof of rate to be enclosed
- 4. No advance payment will be made.
- 5. Payments shall be subject to any deductions (such as TDS etc.) of any amount, for which the Bidder is liable.

J. Penalties -

- Decision as to whether penalties would be levied or not for violation of terms & condition laid down in this tender shall be taken by Secretary, ASRB.
- 2. All the fresh provisions shall be of good quality, stale or rotten vegetables are not to be used. In case stale / rotten vegetables / expired items / sub-standard / adulterated items are found to be used, the same will have to be replaced immediately and a penalty of Rs 1000 would be imposed for every violation.
- 3. Failure to supply food in terms of quality, quantity and as per the purchase order will attract a penalty of Rs. 1000 per violation.
- 4. All the packed/tinned provisions will have to have fssai certification. Use of noncertified provision would not be permitted. If found being used issue would be dealt under the provision of the prevention of food adulteration act 1954 in addition a penalty of Rs 1000 would be imposed for every violation.
- 5. If the delivery is delayed, a penalty of Rs.300/= will be imposed for every hour delay.

- K. Termination of Contract Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:
- 1. The Seller fails to comply with any material term of the contract.
- 2. The Seller informs Buyer of its inability to deliver the material(s) or any part thereof within the stipulated delivery Period or such inability otherwise becomes apparent.
- The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective material(s) promptly.
- 4. The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
- 5. Mutual consent: The contract may be terminated on mutual consent in case the services are no longer required. Termination based on mutual consent will not attract any penalties or shall not be liable for any extra payments other than payment of invoices raised till the time of termination including notice period.

L. Arbitration:

1. If any difference arises concerning this Agreement, its interpretation on the payment to be made there under, the same shall be settled by mutual consultations and negotiations. In the event of any question, dispute or difference arising under the agreement or in connection there with (except as to matter the decision to which is specifically provided under this agreement), the same shall be referred to sole arbitration referred to by Secretary, ASRB. The agreement to appoint an arbitrator will be in accordance with the Arbitration and Conciliation Act 1996 as amended from time to time.

M. Set Off:

 Any sum of money due and payable to the contractor (including security deposit refundable to him) under this contract may be appropriated by purchaser and set off the same against any claim of the purchaser for payment of a sum of money arising out of this contract or under any other contract made by contractor with purchaser.

N. Applicable Law:

 The Contract shall be interpreted in accordance with the laws of the Union of India & will be under the jurisdiction of court in Delhi.

Scope of Work

- ASRB reserves the right to ask for change of items in the meals (packed lunch), other than as mentioned in the Financial bid.
- The quality of food/snacks/ eatables supplied shall be of good quality and hygienic in nature and the service should be to the fullest satisfaction of the Board. It shall be ensured that there is no adulteration of food, milk, etc.
- ASRB shall not provide any utensils, cooking range, electrical milk boiler, electrical water heater, bain-marie, hot case, deep freezer, serving dishes cutleries, fridge etc.
- All the food items should be warm when served, except items intended to be served at room temperature (Sweets, Dahiwada, Salad, etc) or frozen (ice creams).
- 5. All the packed/tinned provisions will have to have fssai certification. Use of noncertified provision would not be permitted. If found being used issue would be dealt under the provision of the prevention of food adulteration act 1954 in addition a penalty of Rs 1000 would be imposed for every violation.
- Number / quantity of lunch / high tea / snacks are bound to change on day to day basis.
- Normally, purchase orders shall be placed a day prior to the date of delivery.
 However, in exceptional / urgent circumstances, orders can be placed on the
 same day. Bidder is bound to accept the orders.
- Orders shall be placed telephonically / by phone / email. Bidder is bound to accept all the orders, irrespective of the mode of placement. Orders shall be given by Section Officer, GA/ Under Secretary, GA or any other officer specifically authorised by the Board.
- The firm shall be liable to provide services even on holidays, in case of emergency.
